Introduction

At Mother Goose Adoptions we value your privacy and are committed to protecting your personal information. This Privacy Policy outlines the types of information we collect, how we use it, and the measures we take to keep it secure. PRIVACY POLICY

1. Consent for SMS Communications

By providing your consent to receive SMS communications, you acknowledge and agree to receive text messages from Mother Goose Adoptions at the phone number you provided.

Information obtained as part of the SMS consent process will not be shared with third parties.

2. Types of SMS Communication

If you have consent to receive text messages, you may receive SMS communications related to the following:

Customers and Guests: Information regarding options for temporary foster care, permanent adoption or parenting resources. You will also receive updates regarding your application, status of necessary documentation, or other relevant information.

Examples: Hi, We wanted to let you know that we received your application. Our next steps will be to request medical records. Once we receive those, we will be in touch to set up your initial intake interview. Reply STOP to opt out of SMS messaging at any time.

3. Information We Collect

We collect both personal and non-personal information from visitors and users of our website. This may include:

- Personal Information: Such as your name, email address, phone number, and any other details you provide through forms on our website.
- Non-Personal Information: This may include browser type, IP address, operating system, and the pages you visit on our site. This data helps us improve our website and user experience.

4. How We Use Your Information

We use the information collected for various purposes, including:

- Providing and maintaining our website and services
- Responding to your requests, inquiries, or customer service issues
- Personalizing your experience on our website
- Sending you promotional information, updates, or marketing materials (with your consent)

- With service providers who assist us in operating our website and conducting our business, provided they agree to keep your information confidential.
- If required by law, to comply with legal obligations or to protect our rights, safety, or property.

7. Data Security

We take data security seriously and implement reasonable measures to protect your information from unauthorized access, disclosure, alteration, or destruction. However, no method of online transmission or storage is completely secure, and we cannot guarantee absolute security

8. Third-Party Links

9. Children's Privacy
